Each corporation of an affiliated group must be treated separately, and each must file a separate application. WHERE MUST THIS APPLICATION BE FILED? With the U.S. Internal Revenue Service Office with which the Federal tax returns are to be filed.

WHEN MUST THIS APPLICATION BE FILED? (a) By those who pay wages, on or before the seventh day after the date on which business begins. (b) By others in sufficient time for the identification number to be included in return, statement, or other document.

ITEMS 1 AND 2. Enter in Item 1 the true name of the applicant and enter in Item 2 the trade name, if any, adopted for business purposes. For example, if John W. Jones, an individual owner, operates a restaurant under the trade name of "Busy Bee Restaurant," "John W. Jones" should be entered in Item 1 and "Busy Bee Restaurant" in Item 2.

NOTE-If a corporation, enter in Item 1 the corporate name as set forth in its charter, or other legal document creating it. If a trust, enter the name of the trust estate in Item 1 and the name of the trustee in Item 2. For an estate of a decedent, insolvent, etc., enter the name of the estate in Item 1 and the name of the administrator or other fiduciary in Item 2.
